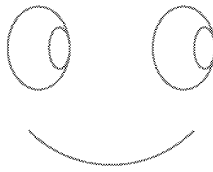


Figure 2.1 Example of Figure

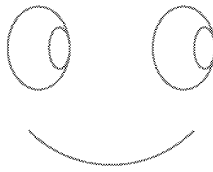


Figure 2.1 Example of Figure
