Entrance Examinations for AY 2023

Regarding the Entrance Examinations for AY 2023, The method of submitting a score report of Private Sector English Proficiency Tests has been changed as follows.

Every applicant who is required to submit a score report of an external English test **must read this document carefully to the end** and please prepare your score sheet well in advance.
